# President's Message

Time was when whaling was done by Captain Ahab and ghosting by Casper. Today the words describe dirty deeds done by scammers. To help you boost your fraud prevention know-how, beware of the following scams.

**Phone Scam:** When answering the phone be aware that you can not trust Caller ID to be correct all the time. Hackers can cause fake names to appear on Caller ID. When answering the phone say "hello" and nothing else. Wait for the caller to say something. If they ask you to identify yourself with a phrase asking, "Is this (using your name)? Do not say, "Yes, it is." Say, "Who is calling?" If you say yes, these scammers record that word and will later use it to purchase items looking like you gave your consent. Usually, they end the call. If they don't, they may want to sell you something like a Medicare brace. Please hang up the phone. Scammers may even say your grandchild has been arrested! Hang up. These are typical scam calls.

**Email Scam:** Scammers are very clever. They send out emails that look like companies that you do business with. Do not respond to these emails. Call the institutions directly.

**Credit Card Scam:** As you go over your credit card bill, look for charges you do not have receipts for, especially low charges like twenty cents or a dollar. This is a scammer tapping your account. It is a test by them. If you do not respond by calling the credit

card company and filing a fraud alert for that amount, the scammer may try to charge something larger to your credit card. Your credit card company will know how to handle this situation. Sometimes, they will issue a new credit card. You can ask your credit card company to email you an alert every time your credit card is used when you aren't physically present at the time of the transaction. This will help you monitor charges on your credit card. If you order something on the internet and use your credit card, they will send you a notice that your credit card has been charged. You can use this notice to verify that the amount of your purchase is the same as the purchase price you clicked on when you ordered the item.

As you travel on this life journey, you may relocate. It is important to notify not only your family and friends of an address change, but also the Chicago Teachers' Pension Fund (CTPF). Please contact Member Services for a change of address form. While you are communicating with them, ask for Form 105 Designation of Beneficiary form to update the beneficiary on your death benefit. Very often family members do not know about this benefit; however, the beneficiary's name and address should be current. If you want a family member or friend to assist you with a health insurance issue, you must submit a HIPAA Authorized Representative Designation Form which is also available through Member Services. If you need a family

member or friend to communicate directly with your health insurance provider, please contact your health insurance provider and have them send you their HIPAA Authorized Representative Designation Form.

RTAC members, I encourage you to share this information with your adult children or a friend. Your adult children or a friend need to know how they can assist you when needed and develop an understanding of what CTPF Member Services can do. As a CTPF retiree you need to register for the CTPF's Member Self-Portal at [myCTPF.org](http://myCTPF.org). This portal includes helpful features to help retired members securely access CTPF documents and information.

Remember be careful. Stay safe.

# RTAC Spotlight on Springfield

At 2:30 a.m. on the Saturday of Memorial Day weekend, the Illinois General Assembly wrapped up its Spring 2023 session. On a party-line vote, Democrats pushed through a \$50.6 billion funding plan for the next fiscal year. It was then signed by Governor Pritzker. The Democrats called the budget “balanced” and “compassionate” while Republicans claimed that it masks hidden costs and fails to address the state’s most urgent priorities.

Citing education as a top priority, lawmakers earmarked close to \$15 billion for education. It includes \$250 million more for early childhood, \$350 million more for the K-12 education evidence-based funding formula, and a \$100 million more for public universities and community colleges as well as an additional \$100 million for MAP grants.

It also includes a \$200 million additional pension payment to the Pension Stabilization Fund. Payments from this fund are to be allocated by the Office of Management and Budget to the five state retirement systems, which includes TRS, but not CTPF.

## IMMIGRANT HEALTH CARE PROGRAM IN THE SPOTLIGHT

The most contentious piece of this budget was the funding for undocumented immigrants’ health care. Initially, \$220 million was proposed but when the cost estimates increased to \$1.1 billion, \$550 million was allocated. The General Assembly also authorized the Department of Healthcare and Family Services to ensure that the program does not exceed the available funds.

Governor Pritzker’s administration announced a “temporary” enrollment pause, capping the number of enrollees and the addition of copays for hospital

visits that are ineligible for matching federal reimbursement

## PENSION LEGISLATION UPDATE

Many provisions of pension legislation were consolidated into one bill - Senate Bill 1646. This pension legislation allows for a teacher who is an elected trustee of the Chicago Teachers Pension Fund to have up to 22 days of paid leave for meetings and seminars related to their official duties.

Legislation stalled that would have included a ‘9% stabilization fee’ to be assessed to returning teachers’ compensation who are to work in areas of need. Senator Martwick and his staff were informed that RTAC did not support the bill and chose to monitor it.

## PENSION HEARINGS TO BE HELD OVER THE SUMMER AND FALL

The budget included an additional \$200 million pension payment beyond the basic required amount, which brought the total pension stabilization investments to \$700 million. In spite of the supplemental contributions, the Standard and Poor credit rating agency warns that Illinois’ “poorly funded” pensions will continue to stress state and local government budgets due to the state’s “weak demographic trends” and “shrinking population.”

To address some of these concerns, State Representative Stephanie Kifowit, the new Chairperson of the House Personnel and Pensions Committee, introduced new pension legislation in the closing days of the Spring session to serve as the foundation for subject matter hearings which are to be held throughout the summer and fall to secure input from all stakeholders. She sees this as an opportunity to address the inequities of the Tier 2 system, identify dedicated revenue sources, and ensure fair benefits.

## OTHER ITEMS WORTHY OF NOTE ARE:

‘Smart Start Illinois’, a multi-year plan that provides additional pre-school slots to make childcare and preschool available to every three- and four-year-old whose family wants those services, stabilize the early childhood workforce, and expand the Early Intervention and Home Visiting Programs.

‘Full-day kindergarten’: mandates that IL school districts have to establish a full-day kindergarten program by the 2027-2028 school year with extensions possible based upon evidence-based funding parameters; and districts with full-day programs can also offer half-day programs.

‘Home Illinois’ adds \$85 million to support homelessness prevention, affordable housing, outreach and other programs aimed at reducing homelessness

‘Re-imagine Public Safety’ provides \$250 million to prevent gun violence and expand funding for youth employment programs.

‘Prohibition of Book Bans’ removes IL state funding from public libraries which remove books and other materials for ‘partisan or doctrinal’ reasons.

‘Lawsuit Venue Shopping’ limits where Illinois plaintiffs can sue over IL constitutional issues to Cook or Sangamon Counties.

‘Chicago School Board District Map Establishment’ postponed for nine months.

‘Invest in Kids’, a tax credit program for private school scholarships, can be brought forward during the veto session.

# Executive Director's Message

The RTAC Office receives many calls from CPS retirees for a variety of reasons. Many are unaware of what led to RTAC's founding and how we continue to serve our members as they address life's challenges. When they become aware of our 97-year history and our mission, they are generally impressed. We continue to focus on advocating to protect retired Chicago Public educators' pensions and ancillary benefits as well as other concerns.

Generally, we are pleased that when they learn about our mission and vision for the future, they are interested in joining us. We welcome and encourage you to assist us in securing new members.

Our membership requires replenishment on an ongoing basis for two primary reasons:

First, although many of our members are living well into their tenth decade, RTAC

receives information on a regular basis from CTPF about those who have made their transition.

Second, due to declining CPS enrollment, there are fewer teachers and therefore fewer retirees who can join the one organization whose mission it is to protect CTPF annuitants' pensions and benefits.

Therefore, we are asking our current members' support in recruiting new and veteran retirees who have as yet to join RTAC. Please direct them to our website – rtac.org – where they can learn more about our organization.

As you interact with those who have as yet to join our organization, please share with them some of the significant actions that RTAC has taken on behalf of retired CPS educators.

1) From 2005 through 2012, RTAC spent in excess of \$97,000 to help settle the Pay Period 13 Case in which 3,600 former CPS educators who retired between 1999 through 2004 were expected to repay the Chicago Public Schools. RTAC, in collaboration with the Chicago Teachers Pension Fund, secured a settlement in which those retirees were spared from having to repay any money to CPS.

2) In 2012, the Illinois Legislature was able to place Amendment 49 on the November 2012 ballot which would have

given local governing bodies the right to determine whether public agency retirees would receive an annual increase to their pensions. RTAC fought to prevent this amendment from becoming law. Had it passed, the Chicago City Council would have been able to determine whether retirees would receive the automatic 3% annual increase (AAI) that CTPF annuitants over age 60 receive every year.

3) In 2017, RTAC was successful in helping to restore the CTPF tax levy from Chicago real estate taxes which was diverted to CPS in 1995.

4) RTAC continuously monitors the health insurance program options that CTPF provides for its annuitants and their surviving spouses to ensure that we have access to quality health care at competitive rates.

As of June 30, 2023, RTAC had 7,326 members. If each current member brings in one new member, our membership level would indeed be strengthened.



## IN MEMORIAM



### Ned L. McCray

RTAC was saddened to learn of Ned L. McCray's passing on June 27, 2023. Ned served as a RTAC Director and President in the last decade of the prior century. He was a very special leader who dedicated his life, personally and professionally, to improving the world. From humble beginnings he demonstrated initiative to succeed on a path of excellence.
