RTAC Salutes the Honorable Jesse Clark White

On Tuesday, May 14, 2024 the Retired Teachers Association of Chicago held its 98th Annual Spring Luncheon/Business Meeting at Macy's Walnut Room. We were especially blessed to have the Honorable Jesse Clark White, Illinois' most recently retired Illinois Secretary of State, serve as our keynote speaker. He is a most unique RTAC life member on a number of levels. He most recently served as Illinois' 37th Secretary of State for six terms comprising a total of 24 years for the period 1999 through 2023, the longest time ever served by an Illinois Secretary of State.


He shared reflections on his unique life of service to Chicago and the State of Illinois. He was born in Alton, Illinois, and raised

on the near northside of Chicago as one of 12 children. Following his graduation from Waller (now Lincoln Park) High School he attended and graduated from Alabama State University. He also served as a paratrooper in the 101st Airborne Division of the U.S. Army. Following his military service, he returned to teach at Chicago's Schiller Elementary and then continued to serve as an administrator for twelve CPS Physical Education programs. He is the beloved founder of the Jesse White Tumblers, which is well renowned in Chicago and across the globe. Jesse is proud that his eponymous team has provided a positive influence for over 20,000 young people who continue to serve as role models for Chicago's youth seeking to lead affirming and fulfilling positive lives. As if that weren't enough he also served as a Representative in the Illinois Legislature for eighteen years and six years as Cook County Recorder of Deeds. His life of service brings honor to retired Chicago public school educators. He is also a revered life member of RTAC. President's Message

RTAC's Spring 2024 was a busy season with two major activities. First, the 2024 RTAC Spring Luncheon/Membership Meeting on May 14, 2024 held at Macy's Walnut Room was a very special event as the Honorable Jesse C. White, an eminent RTAC Lifetime member, served as our keynote speaker. It was my honor as RTAC President to present Jesse C. White with our Certificate of Recognition for his lifetime of service to Chicagoans and Illinoisans. Please see the complete story on page one.

Second was RTAC's legislative focus. In the Spring 2024 RTAC News Bulletin, RTAC was again promoting RTAC's 2024 L.E.A.P. (Legislative Education and Advocacy by Pensioners) initiative to coincide with Leap Year 2024. We encouraged you to contact your Illinois General Assembly Legislators to ensure the passage of IL Senate Bill 2920, sponsored by ILGA Senator Robert Martwick (D-IL. District 10). SB2920 was created to enable CTPF retirees to continue to work as Substitute Teachers for up to 140 days per year for the school years 2024-2025, 2025-2026, and 2026-2027. Had SB2920 not passed, CTPF retirees would only have been able to work up to 120 days without loss of their pensions as of July 1, 2024.

On June 14, 2024, RTAC was pleased to announce via the E-Alert Network that our persistent calls, letters, and witness slips secured passage of IL SB 2920 in the Illinois General Assembly. Matt Maloney, RTAC's Legislative Advocate, was instrumental in spearheading this initiative on behalf of RTAC's members. His and our voices had a significant impact. Governor J.B. Pritzker signed the legislation on Tuesday, June 11, 2024.

Please contact your ILGA Representative and Senator to convey your appreciation for their support. Thanks to all RTAC members who contacted their ILGA Senators and Representatives to solicit their advocacy for this very important legislation. Your efforts made a difference in protecting CPS educators' pensions. If you visited with your ILGA State Senator or Representative in person as part of the LEAP initiative, we hope that you were able to have a photo taken with the individual. If so, please submit it via e-mail as a jpg to the RTAC office at: office@rtac.org. We would like to post it in a future RTAC News Bulletin.

There are those who are saying that "November 5, 2024, is the most consequential election of our lifetime" and I would agree! ALL the members of the ILGA House of Representatives and one-third of the Senators are seeking to serve Illinoisans going forward. In addition, there are many federal, county, and local offices with candidates seeking to represent us at various levels of government. There are those who contend that your one vote does not matter. However, a most recent local example of proof that YOUR ONE VOTE DOES matter occurred in the March 19, 2024, Democratic Primary election for Cook County State's Attorney. Eileen O'Neill Burke was victorious by winning by less than ONE VOTE per PRECINCT, with less than 20% of the eligible voters actually voting.

To learn who represents you, go to the RTAC website section "Legislation and Advocacy" and click on "Find Your Legislator". Insert your address to identify your various elected officials.

Thomas P. "Tip" O'Neill, the late Speaker of the U.S. House of Representatives, was famous for many pithy quotes, including "All Politics are Local". It is applicable in this election in which Chicago RTAC members will be able to elect one representative from each of the city's ten School Board districts to take seats on the Chicago Board of Education beginning in 2025. Mayor Brandon Johnson will appoint an additional ten individuals to represent each of the ten districts plus

the President of the new Chicago Elected School Board. To find out in which Chicago Elected School Board district you reside, consult the website: https:// chicagoelections.gov/news/chicagoelected-school-board-candidates-guideand-district-maps. In 2026, all positions will be elected. As future information about the Chicago Elected School Board election becomes known, RTAC will post alerts on the RTAC website and send them to those who belong to the RTAC E-Alert network. Please accept the responsibility to get information about your district's Chicago Elected School Board candidates from the local media resources so your vote will reflect your unique perspective as a former CPS educator.

Our Chicago Teachers' Pension Fund's (CTPF) 2024 THE BUCK STOPS HERE Education and Advocacy Initiative, (also available online) illustrates the economic and advocacy impact which CTPF members have in Chicago and Illinois. There are 28.052 CTPF annuitants of which 11,198 or almost 40% reside in Chicago. 19th Ward Alderman Matthew O'Shea represents the most annuitants with 3,512 constituents. The ILGA Districts with the largest number of annuitants are: Representative Mary Gill (D-35) with 1,161 and Senator Bill Cunningham (D-18) with 1,919. The total number of CTPF active, inactive, and annuitant members who reside in Chicago is 55,785.

2025-2026 Candidates for RTAC Board of Directors

Each of the candidates is a member in good standing who completed and submitted the RTAC Director Application and Conflict of

Interest forms. The eight slated candidates were presented to the full RTAC Board on Wednesday, August 7, 2024. The eight slated candidates are shown below.

In accordance with the RTAC Bylaws, any other RTAC member in good standing who wishes to run as an independent candidate, must have been a member in good standing as of April 1, 2024, and file the required RTAC Director Application

and Conflict of Interest forms on or before Monday, September 30, 2024, to arcrandall@rtac.org. Failure to submit such forms disqualifies the individual from seeking one of the RTAC Directorships.

The 2024 RTAC Election will be conducted at RTAC's Fall 2024 Luncheon/Business Meeting on Tuesday, October 22, 2024, at Macy's Walnut Room located at 111 N. State Street in downtown Chicago.



ROY E. COLEMAN

Roy Coleman, a Director since 2007, has served as RTAC's webmaster, Assistant Editor of the RTAC News Bulletin and Chair of the Communication/Technology Committee. His 40-year career as a CPS Physics teacher was at Morgan Park H.S., where he initiated

a variety of hands-on experiences, including the annual Bridge-Break competition. An active community volunteer, he oversees RTAC's and CRTAF's websites and facilitates our Zoom meetings. Roy believes RTAC must maintain its position as an independent 'watchdog' to protect retired CPS educators' pensions and ancillary benefits.

viable healthcare options. Bernie is also concerned about those who wish to work as 'guest teachers' to supplement their pensions and has advocated on behalf of those individuals who wish to work up to 140 days without jeopardizing their pensions.



ROSALIE FRUCHTER

Rosalie Fruchter retired from the Dixon Elementary in 2002, where she served as a Reading Resource Teacher, for which she was acknowledged for her leadership roles. Immediately thereafter, she joined RTAC as a lifetime member. Ms. Fruchter has devoted

the intervening years to a variety of community-based educational and religious organizations. She supports RTAC's mission to protect the economic well-being of retired CPS educators and has indicated her willingness to sustain it. She has committed herself to fulfilling RTAC's mission.



JUANITA R. JORDAN

Juanita R. Jordan has served as a RTAC Director for the past ten years. Her CPS teaching career included teaching at the primary level. Following retirement, she proceeded to serve as an adjunct professor for student teachers at St. Xavier University.

May 2024 Social Committee Report

Rita M. Naughton, RTAC First Vice President, who also serves as the Chairperson of the RTAC Social Committee, provided an update on the status of our semi-annual luncheon/business meetings. Rita shared her committee's efforts in finding a suitable, modestly priced venue that can accommodate up to 400 RTAC members, which was our customary group size prior to the pandemic. During their research, Mrs. Naughton's committee learned that hotel banquet facilities charge a 281/2% gratuity plus service charges, whereas restaurants such as Macy's Walnut Room charge an 181/2% gratuity. Macy's Walnut Room has been accommodating and gracious, offering advantageous pricing.

RTAC Spotlight on Springfield

During the May 2024 conclusion of its Spring session, the Illinois General Assembly passed nearly 700 bills. They failed to address all the issues that they faced. No new stadium deals were hatched or approved for the White Sox or the Bears. Lawmakers paid no heed to the demand by Chicago Mayor Brandon Johnson that Chicago is owed another billion dollars. Prison Review Board changes did not advance. Neither was there legislation to put a moratorium on Chicago Public School closures.

RTAC advocated for the passage of IL Senate Bill 2920 legislation which enables CPS retirees to be temporarily re-employed as substitutes for up to 140 days per school year, without loss of their pensions. The June 30, 2024 expiration of the law would have limited retired CPS educators to work only up to 120 days without loss of their pensions. RTAC members called, wrote, and submitted witness slips to extend the sunset to June 30, 2027. SB2920 was passed and the Governor signed the legislation in June 2024. RTAC thanks Senator Rob Martwick for his leadership and commitment on this issue. RTAC's voices were heard.

Governor Pritzker signed the state's \$53.1 billion spending plan for the upcoming fiscal year, the largest in state history. Lawmakers added more than \$1.1 billion in added revenue to balance the budget. These budget and revenue measures passed with only Democratic support in both chambers. Governor Pritzker boasted that Illinois has received nine separate credit upgrades since he took office. He believes that the budget demonstrates "fiscal responsibility" with the \$198 million allocated to the state's "rainy day" fund as well as full FY2025 funding of the State's pension systems.

The State earmarked \$500 million to build a world-leading quantum

computing campus with the expectation that this investment will attract billions in potential private sector and federal government investment. It also supported tax incentives for the film, electric vehicle, and other industries.

Illinois' school districts will receive \$8.6 billion in state funding next year with a \$350 million increase for the K-12 Evidence-Based Funding formula. The Illinois Monetary Award Program will receive \$711 million, up \$10 million from FY 2024. Public universities and community colleges will receive a \$30.6 million increase.

Although it was a contentious issue, the budget also includes \$182 million for migrants and covers \$440 million in health care costs for undocumented individuals.

Lawmakers voted themselves 5% raises, boosting annual pay for all 177 members of the Illinois General Assembly to \$93,712. Leadership and committee chairpersons receive additional compensation.

To pay for the increased spending, the Legislature added \$1.1 billion in revenue from several changes to the State's tax code. It includes a cap on corporate net operating losses that businesses can claim and a tax on companies, like Expedia, that re-rent large blocks of rental rooms. The State increased tax rates on gaming/sports betting and also added a one percentage point increase to the tax on the State's video gambling industry.

Several Democrats did not vote for the budget and there were no Republicans who supported it.

Republicans were highly critical of the budget and argued against the pace of spending growth – increasing spending by 32 percent since Pritzker first took office. They also called attention to the

fact that some of the revenue increases are based on temporary resources which will result in an even tighter fiscal year 2026.

Budget Pressures for the Next Fiscal Year

Transit agencies in Illinois are facing a \$730 million "fiscal cliff" next year due to the end of the U.S.'s COVID-era funding, increasing operating costs, and decreasing ridership. Many lawmakers believe that consolidating the CTA, Metra, and PACE would improve and increase transit usage and eventually lead to savings.

The Governor acknowledged the need to adjust 'Tier 2' pensions for the Illinois public service agency employees whose employment began January 1, 2011, or later. Economists, unions, and stakeholders have repeatedly warned that the retirement benefits in the 'Tier 2' system are so low that they violate federal 'Safe Harbor' laws. Those laws dictate that Social Security Replacement Plans, like Illinois' pensions, must offer benefits that at least match those of Social Security. The General Assembly has been studying the issue in a series of hearings over the past two years. Pritzker's staff stated that he is "open to the conversation" about increasing the cap on 'Tier 2' pension earnings so that they at least match Social Security. However, he cautioned that the cost for such action is unknown at present.

As the November election looms, discussion of the State's finances will be at the forefront of voters' minds as they consider the candidates and their proposals for the future. Addressing 'Tier 2' and other pension costs, fixing transit, funding education, and services to immigrants will be top campaign issues.

Executive Director's Message

Time progresses far too quickly. It seems hard to believe that 17 months from now, on February 1, 2026 RTAC will be observing its 100th Anniversary. We salute our founders who undertook RTAC's mission as the protection of retired Chicago public school educators' economic security. RTAC has continued to focus on that mission consistently through to the present time.

Our history began on December 9, 1925, when the Chicago Board of Education terminated 70 educators who had reached the age of 70 or more. Ten individuals, under the leadership of Dr. James E. Armstrong, filed legal action in the Circuit Court of Cook County to reverse the terminations. Although they were initially unsuccessful, they proceeded to file another legal action in the Illinois State Supreme Court where they were victorious. All of the original terminated educators were given the opportunity to return to their CPS careers as well as others who had been subsequently released from service in Spring 1926. The brave action of Dr. Armstrong and his colleagues led to the passage and enactment of Miller's Law during the 1927 session of the 54th Illinois General Assembly. Miller's Law initiated the establishment of Illinois' Pension Law to protect older educators. Walter R. Miller served as the 11th District Representative during the 54th session of the Illinois General Assembly. He taught at Tilden H.S. during the school year and served in the ILGA during the summers. When he learned about

the matter, he sponsored the first legislation that would protect older educators, which eventually led to the enactment and evolution of Illinois' public school pension law.

From its initial beginnings RTAC, an independent organization, has dedicated its efforts to the protection of CPS educators' economic security and ancillary benefits. RTAC also worked with Ethel Percy Andrus to establish the National Retired Teachers Association in 1947 (RTAC is a charter member) which eventually led to the establishment of the American Association of Retired Persons in 1958. During the nine-plus decades of its existence, RTAC has accumulated a series of victories for Chicago Public School retirees. During the current century, we have:

- 1) Initiated action to address members' rising healthcare costs;
- 2) Created an RTAC Alert e-mail system to notify registered RTAC members about urgent legislative and/or policy matters which require their immediate action;
- 3) Defeated a proposed amendment to the Illinois Constitution which would have compromised all Illinois public agency retirees' annual cost of living increases (AAIs);
- 4) Achieved success in a seven-year legal battle which protected the pensions of 3,700 CTPF members who were threatened when CPS tried to reclaim pension payments;

- 5) Pursued the reinstatement of the real estate tax levy to provide funding for the Chicago Teachers Pension Fund; and
- 6) Persuaded our Illinois General Assembly Representatives and Senators to enable CPS retirees to serve as 'guest teachers' (previously known as substitutes) for up to 140 days without loss of their CTPF Pension Benefits.

We are looking forward to serving as the stewards of our retired CPS colleagues for the generations yet to come. As you interact with former colleagues who have as yet not joined RTAC, please encourage them to join the one organization that has dedicated its entire existence to the protection of retired CPS educators' pensions and ancillary benefits. If you recruit someone to join RTAC as a life member, you and the new life member you recruit will be entered into a special drawing to be conducted at our 100th Anniversary Celebration in 2026.


