## RTAC 99th Annual Fall Luncheon/Business Meeting

RTAC's October 21, 2025 99th Fall Luncheon/Business Meeting was held at Macy's Walnut Room. RTAC President Louella B. Preston presided at the business meeting, which included the election of the 2026-2027 Officers and Directors, a CTPF Health Insurance update from Carrie Berkich, CTPF's Health Insurance Senior Manager, regarding CTPF Annuitants' 2026 Health Insurance options. Ms. Berkich explained the increased pricing for our health insurance prescription coverage and also cautioned against falling prey to commercials and solicitations from a variety of non-CTPF insurance providers, as well as scammers. She related that, unfortunately a substantial number of our fellow CTPF annuitants have been victimized by a variety of tricksters and have lost access to their CTPF health insurance coverage. Reinstatement into the CTPF health insurance program is a complex and prolonged process that is

limited to one reentry per lifetime per annuitant. Caution is advised.

The meeting also included information from RTAC President Louella B. Preston, Patrick M. Keating, Sr., RTAC Second Vice President, and RTAC's Legislative Advocate Matthew Maloney. They explained efforts RTAC's legislative team has undertaken in 2025 to secure a larger subsidy from the Illinois legislature to support our CTPF Health Insurance program, the significant participation of the over 900 CTPF annuitants who submitted 'witness slips' on behalf of SB1893, as well as the status of the Tier 2 situation.

Bernice S. Eshoo, Chairperson of the 2025 RTAC Nominating Committee, presided over the election of the RTAC officers and directors elected to serve for the biennium 2026-2027.

## President's Message

Louella B. Preston, RTAC President

When I began my presidency on January 1, 2024 my goal as Retired Teachers Association of Chicago (RTAC) President was to support RTAC's Mission to serve as the primary advocate for retired CPS educators to the best of my ability. I have tried my best.

RTAC's Spring 2024 was a busy season with two major activities. First, the 2024 RTAC Spring Luncheon/Business Meeting on May 14, 2024 held at Macy's Walnut Room was a very special event as the Honorable Jesse C. White, an eminent RTAC Lifetime Member, served as our keynote speaker. It was my honor as RTAC President to present Jesse C. White with our Certificate of Recognition for his lifetime of service to Chicagoans and Illinoisans.

On June 11, 2024 RTAC was pleased to learn that Governor J. B. Pritzker signed IL SB2920 into law. SB2920 was created to increase the number of days that Chicago Teacher Pension Fund (CTPF) retirees are able to serve as Substitute Teachers from 120 to 140 days per academic year for the school years 2024-2025, 2025-2026, and 2026-2027.

At the 2024 RTAC Fall Luncheon/ Business Meeting on October 21, 2024 I spoke about the new expanded relationship that RTAC had with CTPF. CTPF Executive Director Carlton W. Lenoir, Sr. convened a Stakeholders Meeting of representatives from the Chicago Teachers Union (CTU), the Chicago Principals and Administrators Association (CPAA), and RTAC at the CTPF offices on September 13, 2024. Arlene Crandall, RTAC's Executive Director, Matthew Maloney, RTAC's Legislative Advocate and myself represented RTAC. That meeting resulted in the creation of a CTPF Resolution passed by the CTPF Board of Trustees on September 19, 2024. It is titled "Resolution Affirming the Chicago Teachers' Pension

Fund's Position as an Independent Organization." Stakeholders were urged to develop a supporting document from their respective organizations. The RTAC Board of Directors unanimously approved the "Retired Teachers Association of Chicago's Resolution in Support of Sustaining the Chicago Teachers' Pension Fund as an Autonomous Organization for the Exclusive Benefit of Active and Retired Chicago Public School Educators". Our resolution was incorporated into a letter co-signed by Stakeholders. The letter was sent to all members of the Illinois General Assembly (ILGA) before the 2024 Fall Veto Session. As of this writing, the proposed merger of CTPF with TRS and/or the merger of CTPF's assets with TRS's assets have not been included on the ILGA agenda. The CTPF tax levy has been protected. Our unwavering commitment to CTPF's autonomy has not been challenged.

On January 5, 2025 the "2023 Social Security Fairness Act HR82" that repealed the Government Pension Offset (GPO) and Windfall Elimination Program (WEP) was signed into law by President Joseph R. Biden. RTAC opposed GPO and WEP beginning in the 1980's. In 2015, 2017, and 2019, I represented RTAC at the Conferences of National Retired Teachers Association (NRTA) of which RTAC was a founding member in 1947. The conferences were held in Washington, D.C. and were discontinued after COVID. While I was there, I met with Illinois' two U.S. Senators as well as several IL members of the U.S. House of Representatives to focus on Social Security and Medicare issues. All the federal officials with whom I met assured me of their ongoing support with no thoughts of diminishment. They were true to their word as all of them supported HR 82. Illinois will hold its Primary Election on Tuesday, March 17, 2026 and I hope that you will support the legislators who supported us! Both U.S.

It is noteworthy that all our Democratic Congress persons and one Republican Congressman supported our Social Security benefits.

On March 18, 2025, Patrick Keating RTAC 2nd Vice President, Matt Maloney, and I joined the CTPF team in Springfield to advocate on behalf of the much needed increase to our CTPF health insurance subsidy. CTPF has been receiving \$65 million since 2004. However, that amount is inadequate for the future due to the increasing cost of health insurance/

## Lawmakers Wrap Up Fall Veto Session

The 2025 fall veto session recently wrapped up as lawmakers addressed a wide variety of issues. They passed energy reform initiatives, mental health parity legislation, changes to corporate taxes, and legislation to protect against illegal actions targeting immigrants. They also discussed transit, health care, and pensions.

## Legislature Passes Public Transit Overhaul

After many fits and starts during the past two years, the General Assembly finally came together to pass a monumental transit package. The legislation secures \$1.5 billion for public transportation agencies and reorganizes transit agencies in the Chicago metropolitan area. The legislation averts the fiscal cliff and service cuts, which prevents what lawmakers called "a death spiral," as ridership would decline leading to additional service cuts.

Lawmakers settled on a plan that shifts sales tax revenue from motor fuel purchases to cover public transportation operational expenses and allocates interest from the Road Fund to support public transportation. An additional estimated \$200 million would come from the interest accumulated in the Road Fund.

The plan calls for raising the existing Regional Transportation Authority sales tax by 0.25 percentage points in Cook and the collar counties to generate \$478 million. It increases tolls by 45 cents for passenger cars and by 30% for other vehicles, which will generate up to \$1 billion for the Illinois Tollway. It also prohibits fare increases on public transit for the first year after the bill's passage.

A new transit governance board is part of the reforms that lawmakers demanded. The measure also establishes a new Northern Illinois Transit Authority to oversee CTA, Metra, and Pace with a unified fare system with coordinated fares and schedules. It addresses safety, homelessness, and mental health on public transit. The changes take effect June 1, 2026.

Downstate transit agencies are set to receive \$129 million – well below the \$200 million they wanted. Critics were also dissatisfied with the composition of the Board. It is to be comprised of 20 members: five appointed by Chicago's Mayor, five by the Cook County Board President, five by the Governor, and five collectively by Lake, McHenry, DuPage, Kane, and Will counties.

## Lawmakers Improve Senior Property Tax Freeze

Lawmakers raised the maximum income limit for the Low-Income Senior Citizens Assessment Freeze Homestead Exemption under Senate Bill 642. SB642 raises the maximum annual income to be eligible for certain state property tax relief programs to \$75,000 for taxable year 2026, \$76,000 in 2027, and \$77,000 in 2028 and beyond. The current annual income limit, in effect since 2017, is \$65,000.

## Tier 2 Legislative Fix Passes House Committee, Yet Remains Stalled

Legislation to fix pension benefits for those in Tier 2 advanced out of a House Committee. Among the many changes, the proposal will adjust the salary cap to comply with federal law. It improves the final average salary calculation to the average of the highest six years of an employee's final ten years. The cost-of-living adjustment is 3% simple interest per year. Proponents argue this should address the ticking 'safe harbor' time bomb and help with employee recruitment and retention. The legislation didn't proceed; but there will be continued dialogue on this issue.

#### Senate Committee Hosts Hearing on Retiree Health Care Subsidy

On October 15, 2025, the Illinois Senate Pensions Committee held a subject matter hearing on Senate Bill 1893. The legislation includes an increase to the retiree health care subsidy earmarked for the Chicago Teachers Pension Fund, along with an annual increase equal to the consumer price index.

Senator Martwick stated that the health subsidy has not increased since 2004. To demonstrate support, RTAC and CTPF asked its membership to advocate for the legislation. Nearly 900 people filed 'witness slips' in support. These numbers send a clear message to lawmakers that this issue must be a priority when they return for the Spring 2026 session. No vote was taken, but Senator Martwick plans to call SB1893 for a vote during the Spring 2026 session.

#### Budget Faces Strong Headwinds

Lawmakers face major challenges during the Spring legislative session due to declining revenue and massive federal cuts. Governor Pritzker signed an executive order instructing State agencies to identify up to 4% of Fiscal Year 2026 General Funds appropriations to reserve. Just days after the announcement, the Governor's Office of Management and Budget's (GOMB) report revealed a \$267 million shortfall in the fiscal 2026 budget. That report warns that without significant changes, the deficit could swell to \$2.2 billion by fiscal year 2027.

Massive federal cuts are on the horizon with many set to take effect in 2026. The State faces federal reductions in health care, especially Medicaid, as well as in education and transportation. The State lacks the resources to cover the billions in cuts. Challenging days lie ahead.

## **Executive Director's Message**

## Among RTAC's stellar accomplishments that are worthy of recalling as we approach our Centennial are:

- worked with Dr. Ethel Percy Andrus to establish the National Retired Teachers Association in 1947, of which RTAC is a charter member:
- collaborated with Dr. Ethel Percy Andrus to secure the 1968
   anti-ageism legislation that continues to protect seniors to
   secure wage increases and promotions if/when they choose
   to maintain employment at age 40 and beyond;
- sponsored the election of Edna C. Fanning, the first pensioner trustee on the Chicago Teachers Pension Fund, who also served as RTAC President in 1981-1982;
- secured two additional CTPF pension trustee positions in the 1990s;
- established the Chicago Retired Teachers Aid Fund in 1986 which provides monetary support to CTPF pensioners with diminutive pensions;
- created an Internet web presence in 2000 which enables RTAC members to access legislative and other important information on an ongoing basis;
- collaborated with CTPF in 2003 to address members' rising health insurance costs;
- launched a campaign in the 1980s to eliminate the WEP/ GPO penalties on earned Social Security benefits imposed on public agency employees' Social Security contributions,

- which resulted in the passage of the Social Security Fairness Act (HR82), which was signed into law by President Joseph R. Biden on January 5, 2025;
- established the RTAC E-alert system to notify registered RTAC members about urgent legislative or policy matters which require immediate communication/action with their legislators in 2010;
- defeated a proposed amendment in 2012 to the IL Constitution which would have compromised our CTPF 3% compounded Automatic Annual Increase (AAI);
- purchased a condominium office at the Garland Building on February 1, 2013;
- achieved success in 2016 in securing the restoration of Chicago's tax levy to CTPF which was diverted to the CPS budget in 1995;
- began conducting meetings via Zoom in 2020 as a result of the COVID-19 gathering restrictions;
- secured legislation in 2025 enabling CTPF retirees to work as 'guest teachers' without draconian penalties to their pensions and;
- updated its legislative agenda in 2025 to secure additional support to fund CTPF members' subsidies on their increasing health insurance costs.

Stay vigilant to learn more news of initiatives that RTAC will undertake to protect its fellow CTPF retirees.

We are looking forward to a major celebration in honor of RTAC's Centennial and its history of service to retired Chicago public school educators on May 12, 2026 in the Grand Ballroom of the Hilton Chicago Hotel located at 720 S. Michigan Avenue. prescription coverage. It did not proceed to passage so it remains on RTAC's and CTPF's Legislative Agendas.

On October 15, 2025, CTPF Pensioner Trustee Maria J. Rodriguez spoke on behalf of all CTPF pensioners at the hearing of the ILGA Pension Committee regarding SB1893. Her message was strengthened by the over 900 'Witness Slips' submitted by RTAC and CTPF members. I am sure that as RTAC's Incoming President, Maria J. Rodriguez who was also reelected to serve as a CTPF Retiree Pension Trustee for 2026-2027 will dedicate herself to the passage of SB1893.

On October 21, 2025 the RTAC members in attendance at the RTAC Fall 2025 Luncheon elected four Officers and eight Directors to serve for the biennium 2026-2027. Congratulations and Best Wishes are extended to the incoming officers President Maria J. Rodriguez and 2nd Vice President Carlene Lutz who will join First Vice President Rita M. Naughton, and Treasurer Hubert C. Jackson, Jr. Newly elected Directors are Therese Boyle and Kenneth Klopack who will join returning Directors Lillian H. Degand, Maria Fresse-Giffels, John C. ## Maria J. Rodriguez Testifies in Support of SB1893



CTPF Retiree Trustee Maria J. Rodriguez and Senator Robert Martwick continue to advocate on behalf of CTPF Retirees. Senator Martwick has been a significant ally of retired CPS Educators.

Maria J. Rodriguez, CTPF Retiree Trustee and RTAC's President Elect for the biennium 2026-2027, testified on behalf of SB1893 at the Illinois General Assembly Senate Pension Fund hearing on October 15, 2025 in Springfield. Ms. Rodriguez urged the Committee to pass SB1893 which would increase our CTPF Health Insurance subsidy to ensure the financial security of CTPF's 27,355 annuitants.

In 2004, the subsidy was increased from \$40 million to \$65 million. The current amount will be inadequate to provide the subsidy at the current level after 2026.

RTAC and CTPF sent out 3,172 e-mail messages to their members on Friday, October 10, 2025 urging them to send 'witness slips' on behalf of SB1893. Prior to Ms. Rodriguez' testimony, over

900 'witness slips' were received by the Illinois Senate's Pension Committee which is chaired by Senator Robert Martwick. Although there was no action on SB1893, the number of 'witness slips' that were submitted impressed the legislators. We urge all RTAC Illinois members to contact their Illinois General Assembly legislators to persuade them to move SB1893 forward in Spring 2026. It is in our best interests to contact them to Save Our Subsidy.

## 60% Health Insurance Subsidy Maintained in 2026

Fortunately, at its August 21, 2025, meeting, the Chicago Teachers' Pension Fund Board of Trustees voted to maintain the 60% health insurance subsidy for 2026. It is expected that unless additional funds are provided by the Illinois General Assembly during its Spring 2026 session, our current 60% subsidy may be reduced to 50% for the 2027 calendar year. We also need to contact our Illinois General Assembly legislators to express our concerns about the rising costs of health insurance and medications.

On Friday, October 10, 2025, RTAC was informed that SB1893, sponsored by Senator Robert Martwick, would be addressed during a Senate hearing on Wednesday, October 15, 2025. RTAC was able to send an e-alert to 3,172 RTAC members advising them to send a 'witness slip' to the IL Senate Pension Committee to emphasize the need to move the legislation forward, which aims to increase the current Illinois CTPF health insurance subsidy to \$100 million annually. It was rewarding to learn that over 900 'witness slips' supporting SB1893 were sent. This kind of action helps inform our Illinois Senators and Representatives that we need them to act on our behalf. The number of responses makes a significant impact.



Sometimes, individuals also need help with one-time, unusual expenses, such as large home repairs or other significant costs.
